Together, we are resilient



Macro-financial assistance:

Alleviating the financial pressure on the Ukrainian state, so that it can continue priority expenditures such assalaries and pensions, security, business support, reconstruction services, and support to energy, transport and education projects

- **EUR 1.2 billion** of urgent macro-financial assistance provided (March-May)
- Up to EUR 9 billion to be allocated within a new exceptional aid package (EUR 1 billion already disbursed)
- The European Investment Bank (EIB), with EU budget support, has approved EUR 1.59 billion in support (EUR 1 billion was released in July)



Emergency socio-economic programme:

Access to education, medicine and food, support for local authorities, businesses, and civil society, energy and cyber security, and reconstruction

- **EUR 330 million** allocated to support internally displaced persons and local communities, as well as enterprises, agriculture, infrastructure and other vital areas, to ensure socio-economic resilience
- Support to digital services allowing citizens to inform the government through Diia about property damage, transformation of civic **initiative "Prykhystok"** into a governmental service and simplified compensation for hosts of IDPs with help of EU-supported BRDO

Helping Ukraine to remain stable and fully functioning



Targeted funds and other instruments:

Support to the economy and trade, individual businesses, export capacity

- Customs duties on the import of Ukrainian goods to the EU cancelled for **one year** in early June
- **EUR 120 million** provided by the EU through the European Bank for Reconstruction and Development to support Ukrenergo, Ukrzaliznytsia and the Ukrainian pharmaceutical industry
- **EUR 20 million** allocated by the European Commission to support at least 200 high-tech Ukrainian start-ups
- Around **6 million tonnes** of cereals and oilseed products exported by Ukraine (as of July 2022) thanks to the Solidarity Lanes
- **EUR 1.2 million in grants** for 300 most vulnerable small businesses, procurement of equipment to help SMEs relaunch production
- **Easier business environment** via EU-supported BRDO: development of legislation to **simplify opening**, **moving**, **and running a business at war**



Direct budget support:

needs of critical infrastructure, recovery after the destruction, support to the population and agricultural production, other current expenditures of the state

- **EUR 120 million** of grant funds in 2022 that do not need to be paid back
- EUR 500 million of additional budget support grant funds
- **EUR 668 million** transferred to the Ukrainian budget by the EIB

Together, we care



Support with safety:

Employment, social and medical assistance for refugees in the EU

- **7,5 million** people got shelter in the EU
- **EUR 1 billion** donated by the European Commission during the 'Stand Up for Ukraine' donor conference
- **EUR 3.5 billion** allocated by the European Commission to EU Member States to host Ukrainians
- An EU Temporary Protection Directive provides rights and access to residency, housing, social and medical assistance, as well as care of unaccompanied children and adolescents, education, and jobs¹

Emergency aid through the EU Civil Protection Mechanism (CPM):

Medicine and medical equipment, first-aid kits, ambulances, fire engines, power generators, food, shelter, IT equipment, protective gear and heavy machinery

- Delivery of aid to Ukraine in the largest and most complex EU CPM operation ever (**worth EUR 425 million**)
- Support provided by all 27 EU countries, as well as Norway, Turkey, North Macedonia and the European Commission's 'rescEU' reserve stockpiles
- Over 66,000 tonnes of material aid sent to Ukraine
- Over **1000 patients** in need of medical care sent to hospitals in the EU and Norway

Helping Ukrainians to be safe and secure



Urgent humanitarian aid for those affected:

Food, water, medicine, shelter, cash

- **EUR 348 million** allocated for the primary needs of people affected by the war (including EUR 13 million for Moldova to support Ukrainian refugees)
- More than **11 million** people in Ukraine received humanitarian aid with the EU's contribution from the start of full-scale invasion:
 - **10.2 million** people received food and livelihood assistance
 - **4.4 million** people received health interventions and medical supplies
 - More than 2.2 million people received cash assistance (UAH 2 200) for the purchase of the most necessary goods
 - Over 4.5 million people were assisted with critical protection services
 - Over **4.3 million** people received access to clean water and critical hygiene and sanitation services

Together, we are a force



Weapons, equipment, and ammunition through the European Peace Facility:

- **EUR 2.5 billion** allocated within the framework of the European Peace Facility
- Marks the first time the EU has financed the supply of lethal weapons in this way
- Funds directed to cover the costs of EU Member States providing the Ukrainian armed forces with ammunition and military supplies



Security assistance from EU projects:

Bulletproof vests, first-aid kits, transport, various devices and software

- **EUR 200 million** from the budgets of active EU-funded projects in Ukraine redirected to cover urgent needs in various areas, particularly law enforcement agencies (e.g. Ministry of Internal Affairs, National Police, Prosecutor General's Office, Ministry of Justice)
- **90 vehicles** with a total value of about EUR 2 million delivered by the PRAVO Police Programme
- Modern equipment worth around EUR 356 000 provided by the EU Advisory Mission
- **6 600 items** of emergency aid worth EUR 4 million delivered by the EU Anti-Corruption Initiative
- **1460 items** of emergency aid provided by the EU Pravo-Justice Programme
